

1. 3 Rivers Barrel Racing Association (3RBRA) will govern the futurity, Open, and stallion incentive and reserves the right to refuse entry to any horse or individual. All decisions will be FINAL.
2. The Barrel Futurity is open to any horse that is coming 4 or coming 5 the year of the races. . Front and Back of registration papers must be shown to office when signing up. Unregistered horses must show proof of age with veterinarian's affidavit. If the sire is in our stallion incentive, they are eligible for incentive money.
3. To enter the futurity the horse must never have competed in a barrel race prior to November 15th, 2023. Failure to comply with this rule will result in elimination from futurity and forfeiture of entry fees. All futurity and derby entrants must be checked in prior to competing.
4. Derby/Maturity is open to any horse that is of the age of eight or younger as of January 1st , 2024 (born in 2016). If their sire is in our stallion incentive program, they are eligible for the incentive bonus money.
5. Horses are not allowed to enter the futurity and derby in the same year.
6. Owners do not have to ride horses and riders may ride more than one horse.
7. Dress Code Required: Long sleeve shirts, cowboy boots and hats or helmets.
8. Futurity will be a 2D Payoff on a one second split.
9. The 3RBRA Out West Incentive provides a side pot exclusively for eligible foals sired by stallions enrolled in the 3RBRA Incentive. A Stallion Auction is held annually to raise funds for the Futurity, and Stallion Incentive Side Bonus. Visit our website for a list of all eligible stallions. The stallion must be in the auction that year to be eligible.

For stallion owners:

1. Stallion must be in the incentive that year to be eligible for any incentive funds.
2. To be enrolled for 2022, 2023, 2024 it just requires 1 donated breeding for that year. We will auction the breeding off in our auction in January, and the breeding can be used for the upcoming season. Stallion owners are not required to pay any fees.
3. Starting in 2025 it will either be 1 donated breeding OR \$500 to be enrolled. Stallion owner is not required to do both, they can choose. If the breeding does not sell there are no fees or requirements.

Progeny Rules:

PROGENY ENROLLMENT

1. This fund is available to eligible progeny sired by a current OWBRI enrolled stallion for a one-time fee of \$50 for the life of the progeny, grandfathering in stallions from our 2023 auction as well.

2. For an OWBRI progeny to be eligible for OWBRI Races:

: a. Completely fill out an application

b. Provide a copy of the progeny

Payout: any enrollment fees will go to added money for distribution at the races.

Funding plans:

1. All the funding from the stallion auctions will go towards our 2 Out West races. And any others if we choose to add more. The money raised will be divided between the 2. All funding will be used for added money for the races, and incentives payouts.
2. For 2023-2028 Any offspring of enrolled stallions that enter the incentives side pots and win a check, we will match that check and send to the stallion owner.
3. 2029 and after there will be a race specifically for the progeny of the enrolled stallions, payout as follows: 50% Progeny Owner 30 % Stallion Owner 20% Progeny Owner/Enroller
